CHANGING OF THE GUARD IN THE TOWNSHIP'S PUBLIC SAFETY DEPARTMENT

At the Township Committee meeting on September 27th, Public Safety Director Rich Rosell, who ended a two year stint in that capacity in September, was recognized by the Township for his service to Springfield. He is credited with restructuring both the Police and Fire Departments during his tenure. Police, Fire & OEM each presented him with a plaque for his service to each of their departments over the past two years. Rosell recently accepted a position as Public Safety Director in Dover, NJ.

It also marked the retirement of long time Emergency Management Coordinator John Cottage who is leaving after 38 years in that position and 48 years of service to the Township in Emergency Management. Cottage received a joint resolution from the State of New Jersey Senate and Assembly saluting him for his service. Cottage said that although he is relocating out of state, he hopes to continue to be involved in the various Township special events such as the Free Summer Concert and the July 4th

celebration that he has co chaired with Scott Seidel since 1978. Cottage commented that Springfield is probably unique in the state in that for the past 51 years, there have been only three OEM Coordinators in town.

Scott Seidel, who has served the Township as Deputy Emergency Management Coordinator since 1979 was sworn in as OEM Coordinator to replace Cottage. Seidel will be assisted by Wally Schultz, who was appointed Deputy OEM Coordinator in February of this year.

Earlier this month, Springfield Firefighter Marc Corea was promoted to Captain. Captain Marc Corea started with the Springfield Fire Department as volunteer firefighter in 1997, then was hired as a career firefighter in 1999. He later achieved the designation of Firefighter in Charge. Over his 13 year career, Captain Corea has received several service awards for CPR lifesaving and a group effort for a technical vehicle rescue.

Message from the Mayor

Our last September Township Committee meeting was marked by bittersweet presentations to Office of Emergency Management Coordinator John Cottage and Public Safety Director Richard Rosell. Mr. Cottage was honored on the occasion of his retirement from Springfield after more than 40 years of service to the Township. I presented Mr. Cottage with a Proclamation on behalf of the Township in recognition of his distinguished record of dedication and leadership. He also received a Joint Legislative Resolution from the State of New Jersey prepared by our legislators,

Senator Tom Kean, Assemblyman Jon Bramnick and Assemblywoman Nancy Munoz. Mr. Cottage provided us with his knowledge and experience to guide the Township through emergencies, disasters, utility outages, accidents and the tragedy of September 11, 2001.

Mr. Rosell was also presented with a Proclamation thanking him for his two years of remarkable service to the Township as the Public Safety Director. Mr. Rosell was originally hired with the understanding that his assignment was temporary and limited to two years with the intent of providing guidance, leadership, experience and increased oversight and accountability to our Public Safety departments. He was instrumental to the dramatic turnaround in Springfield public safety and as a result, the community benefited from financial savings that far exceeded his cost to the Township. While his hiring was at times controversial and made to be political, his record speaks volumes and there is no doubt the decision to hire him was the best choice for Springfield. We extend our best wishes to both gentlemen and thank them profusely for their contributions to Springfield. We are proud to recognize these fine public servants for their outstanding work.

The goal of the BID is to use the information to develop a plan for moving forward on improving the economic development of our business districts. REDEVELOPING THE DOWNTOWN

The Springfield Community Partnership is committed to improving the quality of doing business in Springfield for property owners, businesses and residents by making Springfield a self-sustaining, attractive, business destination for consumers and to provide a clean, pleasant shopping/dining/professional environment.

To accomplish this we have been working closely with the Township on redevelopment efforts for the downtown area. The Township had taken the initiative to open up discussions with the State DEP to get a hardship waiver for the flood plain located in this area. The BID has contributed to provide the necessary studies to get this waiver. The Town expects to receive from the State DEP the hardship waiver by the time this article is published. With this major roadblock for redevelopment out of the way the BID is working with the Town to continue the redevelopment process from where it was left off back in 2006.

The BID has hired McManimon, Scotland & Baumann, LLC to provide Redevelopment Counsel Services to the BID and the Township. They will be meeting with the BID Board members, property owners in the redevelopment zone, and Planning Board and Township officials to get their input in putting together a redevelopment plan. The goal is to complete due diligence on the redevelopment area, complete a redevelopment plan, prepare a preliminary financial report on the cost of the projects and the revenue produced by the projects commence discussions with property owners in the redevelopment area by the end of this year.

Springfield: In October 2012 the Springfield Free Public Library will host two lectures on American Presidency presented by Eugene Lieber, retired Associate Professor of History at Essex County College.

On Monday, October 22nd, 2012 at 7:00 p.m. Mr. Lieber will present 'Elections in the American History: The Close and the Controversial'. This program will highlight a number of events in the America's political history when elections remained controversial after the winner was declared. The Bush-Gore election of 2000 was not the first disputed election in the American history.

On Monday, October 29th, 2012 at 7:00 p.m. 'The Growth of the Presidential Power from 1900 to the Present' lecture will highlight how war and other crises have sometimes expanded the powers of the executive branch of the government and the President beyond that established by the Constitution of the United States. War, depression, recession and other crises have contributed to a general increase in those powers over the past 200 years.

Mountain Avenue. School and town officials, along with students from all of the Springfield schools, celebrated the commencement of construction for the Athletic Turf Complex.

"We are embarking on a new era for Springfield sports in creating an athletic complex that the entire Springfield community can be proud of and benefit from," said BOE member, Irwin Sablosky. "We envision the new athletic complex to become a focal point of the town where residents will gather to cheer on scholastic and recreational sports and where our instructional programs in Health and Physical Education can be enhanced and expanded."

The Complex, which will be for all of the Springfield community to use and is estimated to be completed in Fall 2013, will include a football/soccer field, five tennis courts, 500-seat bleachers,

1200 square foot concession stand with storage and restrooms and lights for evening events. The contractor for the Athletic Turf Complex is Rochelle Contracting and the turf is being provided by FieldTurf, Inc.

DOOR TO DOOR SOLICITING

Door to door solicitors, much like telemarketing type telephone calls, can annoy and at times alarm residents who are leery of the individual ringing their door bell. As your police department is fully aware that at times a solicitor feigning going door to door may actually be a criminal looking to break into a home, we ask that residents immediately contact the police department when confronted by solicitors who are not licensed by the town to go door to door or who just make the resident feel uneasy. Police officers will immediately respond to check out any person that is reported to be soliciting door to door in order to verify if the person is permitted to canvas. If an individual is soliciting without a permit, their identity will be established in order to ascertain if this person was merely soliciting without a permit or if this person was in a residential area for a more sinister reason such as looking to burglarize a house or motor vehicle.

Persons seeking to legitimately solicit door to door may do so after applying for a permit from the township clerk's office. In order for a soliciting or peddling permit to be issued, the police department conducts a thorough background inquiry into the individual. This is done so any person permitted to go door to door has been thoroughly checked out so we, your police department, know who is allowed to approach your home to solicit.

When a permit is issued the solicitor is given a copy of the No Knock List. This list is all of the addresses that they are not permitted to approach as the residents on this list have asked the township to not allow solicitors to come to their homes. To have your address added to the No Knock List you need to contact the township clerk's office in person or by phone (973) 912-2200 to request that your address be placed on the list. Upon making your request you will have to supply basic information as to your name, your address and a contact telephone number. Your address remains on the No Knock List for five years at which time you can renew for another five year period. You can remove your name from the list at anytime by simply contacting the clerk's office at town hall.

The problem with solicitors going to an address that is on the list is that only persons who legitimately obtain a permit will obtain a copy of the list. Persons who solicit without first obtaining a permit will merely go from one house to the next. If persons on the No Knock List have someone at their door this may be a solicitor who is going door to door without a permit. If this occurs you should call the police department (973) 376-0400 to report it so police officers can locate and investigate the individual. You can make the call and not give your name if you wish to remain anonymous as our main goal is to locate any person unlawfully going door to door to make sure they are not looking to commit a crime.

The township ordinance for soliciting does exempt various types of groups from having to adhere to a No Knock List. These groups are any township organizations, candidates for election, members of civic organizations, persons distributing political pamphlets and persons engaged in religious proselytizing. If you doubt the legitimacy of anyone at your door just call the police department as it only takes the officers several minutes to see if the person can legitimately go door to door or they are either violating the ordinance or looking to commit a crime.

By contacting your local police on any suspicious or overly aggressive solicitors we can send out a strong message to those persons who canvas in residential areas for less than lawful purposes that Springfield is a town where neighbors watch out for neighbors. The

need for residents to call on anything they deem to be suspicious will enable the officers to locate and apprehend persons who may be soliciting without a permit or who may be someone going door to door to commit a crime ranging from home repair fraud scams to looking for an unattended house to break into and burglarize.

CIVIL WAR AT THE HISTORIC CANNONBALL HOUSE (CBH)

Springfield's Historic Cannon Ball House, located at 126 Morris Ave., will again be part of Union County's Four Centuries in a Weekend on October 20th and 21st. This year is the sesquicentennial of the Civil War battle of Antietam, the single bloodiest day in American history. Fought on September 17, 1862 this battle saw approximately 23,000 men killed or wounded from both the Union and the Confederacy combined. Amongst those mortally wounded was Captain Edward Wade, a resident of Millburn, then Springfield.

In memory of Captain Wade, this Four Centuries at the Cannon Ball House will have a Civil War theme. On exhibit will be different belongings of Captain Wade, including his ceremonial sword, which will be on display at the house for the first time this year. Also to be seen is an authentic newspaper from 1861 reporting the firing on Fort Sumter and the 1862 correspondence of another Civil War soldier, Wellington Briant.

On Saturday October 20th only, the Cannon Ball House's property will become the site of a Civil War battlefield with both Union and Confederate reenactors setting up camp. There will also be a Civilian Soldiers Aide Society display and with a small cannon on the property there is always the chance the Cannon Ball House could always re-earn its name. So join us and hear about Springfield's "boys in blue" and that one Poole brother in grey!

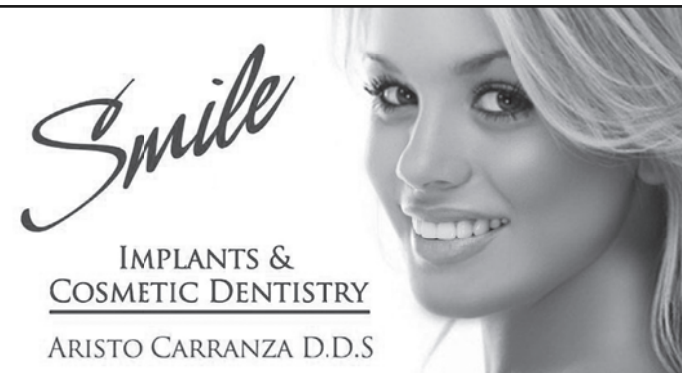

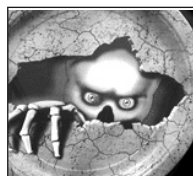

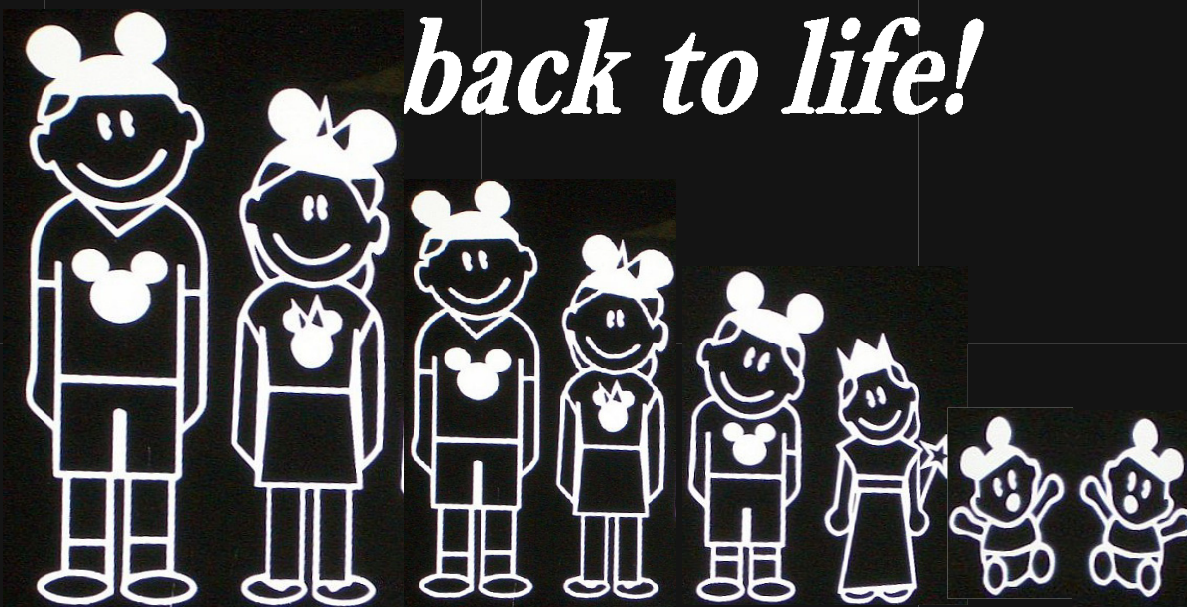
