# TOWNSHIP APPOINTS NEW POLICE CHIEF

With His Children Holding The Bible.

Chief John Cook Is Sworn In As Springfield's Police

Chief By Public Safety Director Richard Rosell

On Tuesday August 9th, the Springfield Township Committee appointed a new Police Chief, Springfield resident John Cook. The Police Department has been without a Chief since March 31, 2010 when the prior Chief, appointed in 1986, retired.

Chief Cook has been the Officer in Charge of the 42 member Springfield Police Department since December 2010. Cook, previously a Captain, with twenty three years of service with the department, has a long list of accom-

plishments and an impressive resume. John joined the Springfield Police in January of 1989. He served as a Patrol Officer reaching first class status and becoming a field training officer for new officers and served in that position through December 2000. He was then assigned to the Detective Bureau where he served the township through May 2006 when he was promoted to Patrol Sergeant, a position he held until being promoted to Captain in the Fall of 2010.

Cook had been the head firearms instructor, the Department instructor for Active Shooter Patrol Response, a certified Drug Recognition Expert, and a co-team leader of an assault team element for the Union County Emergency Response Team,

ERT/SWAT team, being a founding member of the Unit in 1993.

John attended Kean University, graduating in 1986 with a Bachelor of Science degree. He has attended several Executive Management level courses and will be pursuing his Master's through the Master's of Administrative Science program at Fairleigh Dickinson University as well as attending the West Point Command and Leadership Program. John has received numerous service awards from the department along with letters of recognition from other agen-

cies during his career.

Chief Cook believes that police officers have a unique opportunity, by virtue of their wearing a uniform, to make positive changes in the people they encounter and that they should strive in setting a good first impression when interacting with the community and the public at large. He also believes in the Department working "in partnership with the community", as written in the Department's Mission Statement, to continually build better relationships between the police and all who reside and/or work in the community.

John has four children, Vincent, Marissa, Cheyenna, and Morgan ranging from 6 to 18 years of age.

# LOCAL HISTORY by Guest Columnist: Travis Whitehead

William Stites letter of response dated June 8, 1825 To J. L. Edwards Esq, Trenton, NJ Presented in two parts.....

D Sir,

Your favor of the 28th was thankfully received and it is with reluctance that I again trouble you on the subject therein contained. Nothing but a sense of duty could have compelled me to interest myself in favour of the persons whoose pensions I learn with serious regret have been suspended – No one perhaps is more unwilling than myself to see the funds of the General Government lavished or bestowed upon unworthy objects or to see Men who are able to support themselves maintained idley at the Public expense; but my dear Sir the cases before us I am perfectly satisfied are of a different character. I live in the Town of Springfield in the County of Essex and am well acquainted with Mr. Whitehead and Mr. Vreeland and am partially so with M Lacy. As to the pecuinary circumstances of Mr. Whitehead I can say unqualifiably that he ispoor, has been reduced to the necessity of taking

the benefit of the insolvent law of our State about two years since, has raised a large family of Chil dren altogether I think thirteen in number two of which however are lads and are yet home with him and need schooling in order to qualify them to become good members of Society and without the aid which he has thankfully rec'd from his Country I am satisfied he is unable to give them schooling or decently to maintain himself and family. Mr. Whitehead for a Man of his age is healthy and able to do a tolerable days work, but he has a cancer on the side of his neck which I have no doubt will in a short time terminate his existence -- with Mr. Vreeland I have been acquainted from my childhood, he has ever been since my knowledge of him very industriously engaged to provide for himself and family a living - his business was what we call a huckster and from my first recollections of him until the last eight or ten years he drove his own wagon and had two horses, then one and as age and poverty advanced after him he was at last deprived of his own horse and wagon and obliged to abandon his trips to New York which was once regular and some times profitable, now it is but

seldom that he manages to make a trip to Newark or Elizabeth Town with a small load and a hired horse and wagon the proceeds of which must now be so small to need another means of livlihood ( if I may even call it ) of the old man is ( and my sympathies have often been called into exercise at the sight ) on public days at blessings? & to go with his basket on his arm selling boiled eggs, sugar candies & I do not mean to be understood that this is unusual with him but that it is his consistent practice. You will please to pardon me for this account of his manner of getting his living my object is that you may be able to judge of the probable truth or untruth of the allegations of the Memorialist to the War department. It is true that M.V. has a small house and a lot attached to it on which he lives and has the use of I suspect without paying rent for it and no doubt will continue to enjoy it until his death but I never before heard the suggestion made until I read your communication that it had been placed in the hands of his Son as a cover & pretense, I will not contradict it for to me it is new, but cannot believe it and be that as it may with or without it he is poor. It's value consists in making for him and his family a Domocile and furnishes no means or next to none of making a living -

# COMMUNITY CONVERSATION ON ENVIRONMENTAL JUSTICE AT SPRINGFIELD LIBRARY THURSDAY, SEPTEMBER 8 - 7 PM


There will be two face to face "community conversations" on Environmental Justice taking place at the Springfield Free Public Library. The first will be on Thursday, September 8th at 7:00 P.M. The film Crude: The Real Price of Oil will be shown that night. An official selection at the Sundance Film Festival, it provides an inside look at the infamous \$27 billion "Amazon Chernobyl" case. The plaintiffs claim that Texaco – which merged with Chevron in 2001-spent three decades systematically contaminating one of the most bio-diverse regions on earth, poisoning the water air, and land. The plaintiffs allege that the pollution has created a "death zone" in an area the size of Rhode Island, resulting in increased rates of cancer, leukemia, birth defects, and a multiplicity of other health problems.

Following the screening, a discussion will be led by Sarah Walk, Andrew W. Mellon Postdoctoral Fellow in English and Environmental Studies and Sustainability at Drew University.

The second will be a Scholar led reading and discussion that will take place on September 22nd at 7:00 P.M. Four reading selections will be drawn from American Earth: Environmental Writing Since Thoreau, one of the most important works in the environmental movement. Facilitator Sarah Ward will lead a discussion on the topic of Toxins in the Human Environment.

Attendees will receive a reading packet at the time of registration. Registration is required. The Springfield Free Public Library is located at 66 Mountain Avenue, Springfield. For additional information, call 973-376-4930.

# Fire Chief's Column Chief James Sanford

## Fire Safety for College

Every year college and university students experience a growing number of fire-related emergencies. There are several causes for these fires; however, most are due to a general lack of knowledge about fire safety and prevention.

In cases where fire fatalities occurred on college campuses, alcohol was often a factor. There is a strong link between alcohol and fire deaths. In more than 50% of adult fire fatalities, victims were under the influence at the time of the fire. Excessive alcohol consumption often impairs judgment and hampers evacuation efforts. Cooking is the leading cause of fire injuries on college campuses, closely followed by careless smoking and arson.

## Many factors contribute to the problem of dormitory housing fires

- Improper use of 9-1-1 notification systems delays emergency response.
- Student apathy is prevalent. Many are unaware that fire is a risk or threat in the environment.
- Evacuation efforts are hindered since fire alarms are often ignored.
- Building evacuations are delayed due to lack of preparation and preplanning.
- Vandalized and improperly maintained smoke alarms and fire alarm systems inhibit early detection of fires.
- Misuse of cooking appliances, overloaded electrical circuits and extension cords increase the risk of fires.

#### **Safety Precautions**

- Provide students with a program for fire safety and prevention.
- Teach students how to properly notify the fire department using the 9-1-1 system.
- Install smoke alarms in every dormitory room and every level of housing facilities.
- Maintain and regularly test smoke alarms and fire alarm systems. Replace smoke alarm batteries every semester.
- Regularly inspect rooms and buildings for fire hazards. Ask your local fire department for assistance
- Inspect exit doors and windows and make sure they are working properly.
- Create and update detailed floor plans of buildings, and make them available to emergency personnel, resident advisors and students.
- Conduct fire drills and practice escape routes and evacuation plans. Urge students to take each alarm seriously.
- Do not overload electrical outlets and make sure extension cords are used properly.
- Learn to properly use and maintain heating and cooking appliances.
