
TOWNSHIP PASSES RESOLUTION RECOGNIZING THE 10TH ANNIVERSARY OF THE PASSING OF JOSEPH PEPE III

SPRINGFIELD AUXILIARY POLICE PUT NEW VEHICLE IN SERVICE



Auxiliary Police Chief Angelo Palumbo and Emergency Management Deputy Coordinator and Auxiliary Police Captain Wally Schultz put their newest vehicle in service.

The Auxiliary Police just took delivery of their 2014 Chevy Tahoe Police package SUV, which was delivered two weeks ago to Emergency Management. They have just finished installing radios and emergency equipment and having the vehicle lettered. According to Schultz, "This replaces a 2001 Ford Crown Victoria patrol vehicle which no longer suited our needs. The Crown Vic was rear wheel drive and could not be used in snow and ice storms. As we are an emergency response unit, having one of our three vehicles unavailable during an emergency did present problems. Now we have three full size, all-wheel drive SÛVs." Chief Palumbo noted, This new vehicle will help the Auxiliary respond to emergencies and be better prepared to assist the Police Department in all types of inclement weather. We had our monthly meeting the night we put the car in service, and all the members were delighted to see this vehicle enter service. Auxiliary Sergeant Robert Abraham took the car out for the first tour on April 2." According to OEM Coordinator Scott Seidel, "The vehicle bears the unit's new Auxiliary Police patch designed by Auxiliary Sergeant David Root, who assisted in having the new vehicle lettered. Over the next few weeks, our other two SUVs will be re-lettered to match the new car.'





The Township Committee passed a Resolution recognizing the tenth anniversary of the the passing of Joseph Pepe, III, a career Springfield firefighter who suffered a fatal heart attack while participating in a charity basketball tournament at the Caldwell school on the night of March 26, 2004. Message from the Mayor



SPRINGFIELD HADASSAH ANNUAL HADASSAH HOLOCAUST MEETING

She will share her childhood memories of what led to Kristalnacht and the horrors that followed in Nazi Germany. The meeting will also include a moving candle lighting service memorializing the 6 million Jews who perished during the Holocaust. SPRINGFIELD POLICE WORK WITH HOMELAND SECURITY TO MAKE NARCOTICS ARREST

In February 2014, the Springfield Police Department was contacted by agents of the U.S. Customs & Border Protection reporting their discovery of multiple packages of anabolic steroids being sent to a home in Springfield through the U.S. Mail. The packages were being shipped from an address in the Republic of Moldova, a country located in Eastern Europe. Springfield police detectives arranged to deliver the packages along with the assistance of agents from the U.S. Department of Homeland Security. The packages were delivered to the resident by an undercover detective posing as a delivery person and on 03/07/2014 the resident, William Prokos age 35 of South Maple Avenue, was arrested by Springfield police and charged with multiple narcotics offenses.

Prokos was taken into custody by Springfield police detectives after signing for the packages that were addressed to him and a total of fifty-five (55) separate vials of steroids were seized. According to U.S. Customs the vials contained steroids with an estimated "street" value in excess of \$6,000. Anabolic steroids are a Schedule III narcotics and require a valid prescription in the State of New Jersey.

Prokos was charged with Possession with Intent to Distribute a Controlled Dangerous Substance, Possession of a Controlled Dangerous Substance, Possession of Hypodermic Needles, and Possession with Intent to Distribute a Controlled Dangerous Substance within 500 feet of a Public Park. The park in question being the Trivett Park located between South Maple Avenue and Colonial Terrace. The case is awaiting presentation to the Union County Grand Jury in the Union County Superior Court in Elizabeth NJ.

According to Police Chief John Cook, "This cooperation between federal and local police agencies demonstrates that persons cannot go half way across the globe in order to engage in criminal activity in violation of the law in order to escape detection and this operation demonstrates that the Springfield Police Department will take all appropriate action to address complaints of suspect drug dealing anywhere in Springfield and especially in areas close to parks and playgrounds utilized by children."

WOMEN'S HEALTH SCREENING

Women due for a gynecological check-up are invited to sign up for an appointment with the Madison Health Department. The check-ups are open to all women who live in Madison, Chatham Borough, Chatham Township, and Springfield, including nannies and other household employees and those without health insurance coverage. Regular check-ups are an important part of staying healthy.

The screening will be held at the Madison Health Department located in the Civic Center, 28 Walnut Street, Madison on Monday, May 12 starting at 9:30 am. Appointments are necessary and may be made by calling 973-593-3079 ext.1 beginning on April 17. A \$25.00 fee may apply if a Pap test is indicated.

This comprehensive check-up for women will include manual breast and pelvic exams, colo-rectal exams, blood pressure checks, and education on the technique of monthly breast self-examination for each participant. Dr. Rohini Jobanputra will determine with each woman if a Pap test is advisable for her.

Healthy habits for women in addition to annual check-ups include engaging in physical activity most days of the week, eating a nutritious diet that includes lots of fruits and vegetables, and avoiding high risk behaviors like smoking and not wearing a seatbelt. Women are often the caregivers for their spouses, children, and parents and forget to focus on their own health. Research shows that when women take care of themselves, the health of their family improves. When women take even the simplest steps to improve their health, the results can be significant and everyone will benefit.

The Madison Health Department encourages women to sign up for the screening and also to pass the word along to other resident women who may not know about this service. Call the Madison Health Dept. (973-593-3079 ext.1) for an appointment for yourself or a loved one. Participants should have their physician's name and address ready when they call.

TOWNSHIP STARTING STREET PAVING PROJECTS

The Township Committee approved funding for street improvements to pave eleven roads throughout the Township. Road improvements include paving, drainage, and curb installation, where necessary. Work has started on the following roads:

- Warwick Circle
- Bryant Ave on or about March 31 through April 4
- Park Lane on or about April 4 through April 18
- Chimney Ridge/Rolling Rock on or about April 2 through April 25

Design work is being done now for the following roads and paving will occur later in the year:

- Redwood Road (from #17 to South Gate)
- Lyons Place
- Battle Hill Avenue
- Hawthorne Avenue
- Crest Place
- Short Hills Avenue (Morris Avenue to Tulip Road)

• Remer Avenue (Mountain Avenue to Wentz Avenue) All streets will get advance notice from the Township by the CodeRed calling system and by the contractor selected to do the work. We will also post notifications

on our website and on the Township Facebook page. Any questions on paving should be directed to the Springfield Engineering Department at 973-912-2219.

TOWNSHIP RECEIVES \$10,000 GRANT FOR RAIN GARDENS

The Township received a \$10,000 grant from Sustainable Jersey, funded through PSE&G to fund a creative project, in cooperation with Rutgers University (Rutgers) to build up to six rain gardens to absorb runoff from rooftops, sidewalks, parking lots and streets. The goal is to utilize these rain gardens as educational tools to encourage residents, commercial property owners and developers to put them in on their own properties. Compared to a patch of lawn, a rain garden allows about 30% more water to soak into the ground. Rain gardens mimic natural hydrology by infiltrating and evapotranspiring runoff and act as versatile feature that can be installed in most unpaved spaces

The Township's goal is to promote rain gardens with residents and commercial property owners of Springfield so that they will adopt this best practice on their own properties. This project is part of a larger watershed wide effort started in 2013 called the 1000 Rain Gardens Project (https://www.facebook.com/1000 RainGardensProject) sponsored by the Rahway River Stormwater Advisory Board. Municipalities throughout the watershed, including Springfield, have committed to installing 1000 rain gardens in an effort to reduce stormwater runoff from impervious surfaces and control flooding. The 1000 Rain Garden Project already has enormous momentum. Springfield has been a leader in the effort currently assisting the Rahway River Watershed Association in finding rain garden champions and coordinating watershed-wide municipal trainings on rain garden planning and installation, which will occurred in February and

In addition, this project will be used as a citizen education/engagement project to build awareness about native plants, species diversity, stormwater management, and habitat restoration so that citizens and commercial property owners have local examples to turn to when looking to improve their own residential environments.

Three of the rain garden projects will be planned and designed as demonstrations.

For at least one of the proposed rain gardens a design process will be developed that includes students from the Environmental Club at Jonathan Dayton High School (JDHS), guided by science teacher and Environmental Club advisor Bryan Davison. Through education and collaborative design sessions with students, Rutgers professors will develop a replicable process for the design and implementation of rain gardens by students. Students will learn how to identify potential sites, evaluate native soils for infiltration, create preliminary grading and layout plans, and learn how to install plant materials. This process will be published on the Township website and Rutgers sites to facilitate its use and adoption by other schools. Rutgers professors will be available for

consultation with towns interested in replicating the design process.

A unique partnership has been formed with the Springfield Environmental Commission, Springfield Green Team, Rutgers the Springfield Board of Education (in conjunction with the JDHS Environmental Club and science teacher Bryan Davison) and the Springfield Free Public Library. In addition, the Springfield Township Committee created a Flood Mitigation Advisory Committee, who will be part of the grant focus to ensure actions that are taken in the Township do not exacerbate stormwater runoff and flooding. Finally, the United States Environmental Protection Agency (USEPA), Region 2 has agreed to provide technical assistance to the Township. All of these partners will be our Rain Garden Team (see attachment A, Rain Garden Team/Partners).

A planning meeting will occur in April with all the partners to start the implementation process.

SPRING HAS SPRUNG – TIME TO CLEAN YOUR YARDS!

Starting April 1 through April 30, the Springfield Department of Works (DPW) will pick up yard waste including: leaves, brush, vegetation and grass clippings. All material must be in paper bags or garbage containers – NO PLASTIC BAGS

Bagged or material in garbage containers should be put to the curb and DPW will pick up. Residents can also call DPW at 973-912-2224 or 8483 and let them know location of material that needs to be picked up.

Spring is also a good time to check outside your home and cleanup or make needed repairs. Some areas to check and get a jump on your tasks:

- * Replace damaged, rusted or broken storm doors and assembly hardware.
- * Replace broken doorbell buttons and outside electrical outlet covers.
- * Clean all gutters and downspouts on the house to ensure they are not blocked with debris.

 * Fix or replace draperies, shades or blinds that are torn,
- faded or broken.

 * Replace ripped screens, cracked windows and door
- glass.

 * Remove shovels, empty/broken pots, fertilizer soil
- * Remove shovels, empty/broken pots, fertilizer soil bags and broken rusted garden ornaments from planted beds.
- *Remove empty pots, dead plants, stems, flowers and weeds and cleanup patio areas.
- *Store bikes, toys, basketball stands and lawn furniture inside when not in use.
- *Remove dog waste from your yard and common areas.

Police Chief's Column Chief John P. Cook

All recipients of the Springfield Patriot Times, especially homeowners are advised that during the spring and summer months various types of con artists come into New Jersey and other northeastern states and target residents, usually senior citizens or the elderly. These criminal groups are referred to as "travelers" as they travel throughout the country committing any of a series of fraud schemes that can range from attempting to receive payment for home repairs that are not done or are done in a substandard fashion to attempting to con their way into a house to steal money or jewelry.

HOME REPAIR SCAMS

The homeowner is solicited at their house by persons claiming to be working in the area on driveway paving and they offer to repair or replace the victim's driveway with the left over materials they have. The scam is where the fraudsters will either do limited cosmetic work by filling in cracks and they will then spray some type of mixture of black paint and oil to make it appear that the driveway was repaved. No contracts are used and the actors will usually request payment in cash or a check made payable to cash. In some cases the checks will be altered to a higher amount when cashed by the suspects.

Homeowners, especially persons who recently purchased a house, will be solicited either by phone or at their door by persons claiming to represent some type of chimney cleaning service where the victim will be told that the prior homeowner had an annual contract to have the chimney inspected and/or cleaned. The inspection fee is always a small amount of money usually under \$50.00. If the homeowner agrees to have the chimney inspected problems will always be found which will range from cracked chimney bricks or broken flashing on the roof to a blocked flue at the furnace, that victim is told will cause a life threatening build up of carbon monoxide in the house. When the victim agrees to having the repairs made, they cannot see if anything was done on the roof and in some cases the supposed work done to the furnace actually creates a problem where one had not existed.

UTILITY IMPOSTER SCAMS

Fraudsters pose as employees for a utility company to con their way into the house. They will use ruses such as needing to inspect water pipes in basement, or gas or electric and in some cases they will carry a clipboard with various papers and a \$100 bill clipped to the top of the papers. The actors inform the victim they are receiving a rebate from whatever utility company the pretend to represent but the rebate is said to be only \$80.00 and the actors require the victim to make change for the \$100 bill. This is done so the actors can see where the victim goes inside the house to retrieve the money. In all utility imposter scams the actors will require the victim to bang on pipes under the kitchen sink or to accompany the worker into the basement. A second actor who was unseen but with the utility imposter will then enter the house and search rooms to steal money and jewelry. The utility companies never issue any type of rebate by having someone bring cash to a house and utility company employees will have a visible photo ID card issued by the company they work for. Lastly, utility companies call or send letters to customers if an employee needs to come to a house for any type of problem or routine inspection.

HOMEOWNER DISTRACTION SCAMS

These are scams where the actor will attempt to lure a resident outside of their home and into the rear yard in the hopes the victim leaves the front door open or they will attempt to con their way into the home so that one actor can go to bedrooms to steal money and jewelry. Most common are males claiming to be doing work at a neighbor's yard and they need to ask a question about a tree or other object in the rear yard. Once they lure a victim into the rear yard they use cell phones to communicate between the male(s) in the rear yard and the actor who enters the house. Other ploys have females asking for help in catching their runaway cat that is supposedly in the victim's rear yard.

The cons to enter the house usually consist of actors claiming to be selling something door to door, taking some type of survey to looking for an address on the street. Actor will ask for drink of water or to look at a phone book or ask for a pen and paper in order to leave a note for a neighbor. Once they can get into the house they will try to steer the victim into the kitchen while another suspect goes to the bedrooms.

Do not open your door to strangers or persons claiming to be utility workers who are at your house for some type of inspection, especially if you did not set up the inspection or were informed of it in advance by the utility company. The legitimate employee not only has ID but will have a vehicle that bears the name and logo for the utility company they represent. Police officers will immediately respond to your residence if you call about a suspicious person or doubt the legitimacy of a utility company worker. If you believe a person at your house is attempting to commit one of these types of crimes, contact the police immediately via 9-1-1 or (973) 376-0400.

Have you noticed these signs on your own lawn or on our neighbor lawns? The little yellow signs state the following: CAUTION-Pesticide Application-Keep children and pets off the area. If the pesticides applied to the lawns are not safe for our children or pets to play on, shouldn't we worry that these pesticides are going into our groundwater and our environment?

Pesticides in the environment are a concern because:

- Synthetic pesticides can cause cancer, learning disabilities, asthma, birth defects and reproductive
- Children face higher risks than adults from synthetic pesticides because they are developing
- Synthetic pesticides leach into water supplies

As spring approaches the Springfield Environmental Commission would like to take a moment to advise our neighbors on safer alternatives for you and for your landscapers to use!! Natural alternatives don't have to cost more than synthetic pesticides.

- Tips and Facts:

 1. MAKE SURE YOU ASK YOUR LANDSCAPERS TO USE ORGANIC OR NATURAL MATERIALS, NOT SYNTHETIC PESTICIDES!!!!
- 2. When buying a product choose natural ones such as milky spore and nematodes.
- 3. Remember that all pesticides are poison and are considered by the EPA to be hazardous waste. For example, the "Weed" portion of "Weed 'n' Feed" products are pesticides.
- 4. READ the Labels Poison, Danger, Warning, and Caution: These words indicate the level of hazard associated with the product in decreasing order of toxicity. 5. Just because a product is registered with the EPA does not mean it is safe!
- 6. To dispose of pesticide leftovers, read their labels and bring them to the hazardous waste collection center.
- 7. The empty containers are not recyclable so dispose of them as refuse
- 8. A frequent mistake made by many homeowners is to apply unnecessary chemicals.
- 9. What the turf can't absorb will soon be carried away by rainwater or snow melt, to end up untreated in our regional watershed.
- 10. Never apply chemicals before it rains.
- 11. Discover the many benefits of using organic lawn care products and natural alternatives to pesticides, such as a corn gluten product.

Doing it yourself without a landscaper?

Some helpful tips:

- 1. Fertilize organically twice a year.
- 2. Mow high (3 inches) and weeds will die naturally. 3. Water wisely- A good deep soaking early in the morning.
- 4. Re-seed lawn in spring and fall.
- 5. Use top dressing (a 50/50 mix of compost & top soil).
- Never apply any product before it rains.





Fire Chief's Column

9-Volt Battery Safety

We use 9-volt batteries power our smoke alarms, household items and toys. They can be found in most homes. According to the National Fire Protection Association (NFPA), these batteries can be a fire hazard if not stored safely or disposed of with care. The problem is 9-volt batteries can be dangerous. The positive and negative posts are close together. If a metal object touches the two posts of a 9-volt battery, it can cause a short circuit and enough heat to start a fire.

It is unsafe to store 9-volt batteries in a drawer near paper clips, coins, pens, or other batteries. Do not store common household items such as steel wool, aluminum foil, and keys near 9-volt batteries. If these items touch the two posts, there is a greater risk of a fire starting. Weak batteries may have enough charge to cause a fire. Some fires have started in trash when 9-volt batteries were thrown away with other metal items.

In cooperation with the NFPA, the Springfield Fire Department offers the following recommendations for the storage and disposal of 9-volt batteries:

- Storage: Keep batteries in original packaging until you are ready to use them. If loose, keep the posts covered with masking, duct, or electrical tape. Prevent the posts from coming in contact with metal objects. Keep them someplace safe where they won't be tossed around. 9-volt batteries should not be stored loose in a drawer. Do not store them in containers with other batteries.
- Disposal: According to the New Jersey Dry Cell Battery Management Act, household battery compositions are less hazardous and can be thrown away with regular trash. To be safe, cover the positive and negative posts with masking, duct, or electrical tape to prevent contact with metal objects in the trash.

As of January 1, 2010, many municipalities in Union County will no longer accept batteries either at their recycling centers or with the curbside collection of recyclables. Rechargeable batteries can be recycled at participating retail locations including the following: Radio Shack, Best Buy, Staples, Target, Office Max, Lowes, Home Depot, Sears, Wal-Mart and Verizon Wireless. To find a retail collection site, use the collection site locator at www.call2recycle.org or call the consumer helpline, 1-877-2-RECYCLE.

FIRE AT 15 BATTLE HILL AVENUE

On March 13, 2014 at 6:54 pm, the Springfield Fire Department dispatched all units to a reported building fire at 15 Battle Hill Avenue. The first engine company arrived and reported a two-story wood frame single family residence with fire showing from a first floor window. The residents were not home when the fire started.

Springfield Engine 4 began an interior fire attack and requested a second alarm. Deputy Fire Chief Carlo Palumbo arrived and assumed command. Springfield was assisted on the second alarm assignment by Union, Millburn, Summit and Westfield Fire Departments. Springfield First Aid Squad and the Union County EMS Task Force provided rehabilitation support to the firefighters.

The fire was confined to the first floor with heat and smoke damage to the second floor. The fire was placed under control at 7:29 pm. There were no reported injuries to firefighters or residents. The Union County Fire Investigation Task Force is investigating the cause of fire which appears to be accidental. Deputy Emergency Management Coordinator Wally Schultz of the Springfield Office of Emergency Management in conjunction with Springfield HOPE assisted the residents with relocation, and the Springfield Auxiliary Police and Police Department were on scene to assist with traffic control.


