Springfield firefighters are supporting Autism Awareness Month, a global initiative held every April to raise awareness, knowledge and understanding of the issues affecting those with Autism Spectrum Disorder. This training improved their understanding and sensitivity towards those with Autism Spectrum Disorder and how to better interact during emergency situations.



LIBRARY AND HISTORICAL SOCIETY CELEBRATE 220TH ANNIVERSARY OF SPRINGFIELD TOWNSHIP

The 220th anniversary of the Township of Springfield is April 14, 2014. On that date, the very first township committee meeting was held (Springfield had petitioned the State Legislature in 1793 to be recognized as independent of the Township of Elizabethtown). There will be a month-long celebration of this anniversary, kicking off with a concert of colonial music by the musical duo The Tuckers at 2:00 pm on Sunday, April 6. Their performance will feature songs from the colonial hit parade such as "Antediluvians Were All Very Sober," "Battle of Trenton," "Four Drunken Maidens" and "Soldier Will You Marry Me?" along with more familiar tunes such as "Yankee Doodle," "Greensleeves," and "Water is Wide."

April 6 will also mark the opening of an exhibit at the library's Donald B. Palmer Museum of various items from the history of Springfield, including news coverage of significant events that mark the evolution of the township. The doors to the museum will open at 1:00 pm. The Historical Society and the library will also have

available for sale that afternoon a number of books and items pertaining to Springfield's history, including *Images of America: Springfield, Phoebe's Notebook*, and maps and informational booklets pertaining to the Battle of Springfield.

The library owns the original minutes of every township committee meeting from the first one held on April 14, 1794 through 1909. These are bound in a single volume and have recently been digitized. A facsimile copy of the entire volume was produced and is available to the public for perusal at the library. Another facsimile copy has been made and will be presented to the Township Committee at their meeting to be held on April 8.

TOWNSHIP COMMITTEE UPDATE - FEBRUARY 2014

The workshop meeting of February 10 at the Firehouse included reports from all the department heads with opportunity for discussion by the Township Committee members and the public. The Township Administrator and the department heads also presented their goals for the coming year, which were also available for discussion. The DPW sub-committee (Mr. Shehady and Mr. Fernandez) presented a report on the proposed transfer of three employees of the Recreation Department to the DPW. Their conclusion was that such a move was not merited, an opinion in which the majority of the Committee concurred.

At the first regular session on February 11, several announcements of upcoming events were made, including a planned program on Stormwater Management for NJ Municipalities sponsored by the Rahway River Watershed Association to be held on Tuesday, March 25 from 7:30-9:30 at the Millburn Town Hall. A number of routine resolutions were passed and payroll and invoices for the preceding two weeks were approved. One of the resolutions introduced and approved the proposed 2014 budget for Springfield Community Partnership (BID). Another significant resolution, 2014-59, urges that the Governor and the state Office of Emergency Management to request that FEMA reimburse Springfield and other municipalities for the "great and unanticipated costs" incurred by the severe weather we have experienced this year. Copies will be sent to other local, county and state officials urging their support for this aid. There was the First Reading of Ordinance 2014-01 authorizing various improvements to the Municipal Pool and the necessary bonding to pay for them. The second reading and vote will be held at the March 11 meeting.

The second regular session was held on February 25 and was relatively brief. Along with the usual approval of payroll and invoices and several resolutions, the mayor was privileged to swear in Probationary Fire Officer Antonio De Campos. An Executive Session was also held on a matter that remains confidential at

INTERNET FRAUD SCAMS

In the past, persons who were the victims of bunco scams or confidence schemes were looked upon as being somewhat complicit in the fraud acts committed against them under the old adage of "you can't cheat an honest man." Today that saying is no longer true as fraud scams are now designed to target unsuspecting persons through sophisticated cons with the use of modern technology. Nowadays the internet and the telephone make it extremely possible and sometimes very easy to "cheat an honest man." I would like recipients of the Springfield Patriot Times to be aware of some of the more prevalent scams that have been committed against township residents in the past several months.

Most fraud scams that specifically target residents are done via the internet or via the telephone and are designed to obtain either money from or the personal identity information of the intended victim. This will be an attempt to have money wired to the fraudsters or obtain credit account numbers or identity information such as a Social Security number.

• Any mail received or an internet email or even a telephone call that indicates a resident is a winner of any type of sweepstakes or foreign lottery where some type of monetary fee is required to be paid, this is an outright scam. If you did not enter any sweepstakes or participate in any foreign lottery, there is no way you can be a winner. Whenever fees are required to be paid in advance in order to collect the supposed prize, this is a scam to con you out of your money. For any prize to be legitimate there cannot be any monetary fee requested in order to collect a prize

• If you are selling an item over the internet or you advertise some type of service that you perform, be wary of persons who contact you wanting to purchase items you've listed for sale or wanting to pay you for the services you offer where the subject pays by check which is payable to more moneys than were agreed to. This scam specifically wants the intended victim to believe that the check was made out in the inflated amount by accident and will attempt to have the victim wire any monetary difference before the actual check is discovered to be counterfeit. The suspects will always be out of state or in a foreign country but will claim to be in the process of moving into Springfield. The scam targets persons selling any item from a car to a couch or offering services from baby-sitting to piano lessons.

• Do not give out personal information to callers who claim to be representatives of your bank or any business you may have a credit account with. The fraudster may also pose as a law enforcement official with the call pretending to be some type of investigator into fraud on your account. This is done to con you into giving out a Social Security number or other personal information when the caller asks you to prove your identity. Remember that anyone who calls you should already know who you are and you do not have to give out confidential information in order to prove your identity. This same scam, known as "phishing" can

also involve bogus emails purporting to be from a financial institution or governmental agency and is intended to con you into divulging your identity information.

• Be wary of the "one ring cell phone scam" as falling for this could cost you hundreds of dollars. Scammers will randomly call blocks of numbers and will only let the phone ring once as this is enough to cause a missed call message to pop on your cell phone. If you call back the number you will actually wind up calling adult entertainment type phone services located in foreign nations in the Caribbean. The cheaper phone numbers charge you \$19.95 for an international call fee with an additional \$9.00 charged per each minute. Some of the area codes used with this scam are: 268, 284, 473, 809 and 876. In other scams you may receive a phone message where the caller leaves a generic message that a family member has been hurt or has died and you are asked to call a number that has one of the above area codes and when you call it back you are deliberately stalled and put on hold to accrue extra minutes with some of the foreign scam numbers being known to actually cost hundreds or thousands of dollars per minute. If you do not recognize the number do not call it and instead check it through Google to see if this number has been already reported as a fraud as it most likely will have been.

• Do not fall for someone who calls you claiming to be a police officer or a federal law enforcement agent AND who tells you there is a warrant for your arrest but that you can post the bail over the phone. The imposter will claim that instead of the officers coming to arrest you at your home or business you can "post bail" by either giving up your credit card number or by going to a store to purchase a Green Dot VISA money pack preloaded debit card. If you opt to do the latter you will purchase the card in the specified amount of the "bail" and then call the phone number you were given by the imposter to relay information from the card. If there is a reason, law enforcement may come to your house or business to arrest you but will never call ahead and then agree to accept bail money over the phone.

If you believe you have received a call or an email for any of the aforementioned or similar scams, you can contact the police department at (973)-376-0400 and an officer will meet with you to determine if this is a scam attempt. The one call that you make to your local police may save you hundreds if not thousands of dollars due to falling for one of these fraud calls that are being made more and more each year.

Community Pool Improvements Completed, In-Progress And Anticipated

2010/2011 - The Township spent approximately \$240,000 to make the following improvements:

Pool was completely drained and sand blasted; new tile work was installed around the entire top section of the pool; new lane line tiles were installed; new depth marker tiles were installed; three coats of rubberized based paint was applied; various coping was replaced or fixed surrounding the Community Pool area. The wading pool was completely drained and sand blasted; new tile work was installed around the entire top section of the pool; concrete areas around return skimming basket areas were redone; new depth marker tiles were installed; and three coats of rubberized based paint were completed.

2012/2013 - The Township spent an additional \$200,000 for the following improvements to:

Install a new filtration system and piping. A new main Community Pool cover has been delivered and will be used to cover the pool at the end of the 2014 season.

The Township Committee recently approved additional 2014 funding to:

Make bath house improvements which include the repair of the men's bathroom floor pitch for drainage; non-slip tile in the men's bathroom and shower room and the women's bathroom and shower room; sink and toilet auto-flush equip-

ment; replacement of shower equipment; additional locker room benches and non-slip matting in locker rooms. Plumbing fixtures will be replaced as needed throughout the building.

Purchase a new swim Community Pool commercial slide and installation. A single vortex slide, including a full size staircase for safety, is to be installed by a contractor.

Purchase and install three permanent shade structures approximately 20 ft. in area. These three structures will create a large amount of shade area on the grass sections of the Community Pool complex.

Purchase and replace seven lifeguard approved stands to increase coverage in heavily used areas of the Community Pool complex during different events. All stands will have safety umbrellas for guards.

Purchase additional new lounge chairs and single sand chairs for the Community Pool members and guests.

Purchase new Community Pool vacuum system and associated equipment, attachments, lengths of hose, cleaning and skimming accessories for use with the vacuum for the maximum cleaning of the main and wading Community Pool areas.

Purchase and replace the easy-access ADA staircase. This is an item used for individuals with disabilities as well as the senior citizen members. Improve front entrance of Community Pool building to include sidewalk replacement and the approved ADA ramp access from the parking lot area to the sidewalk area. In addition, various improvements to the concrete walkways inside the Community Pool complex, concession area and the Community Pool apron areas will be undertaken.

Purchase and install new ice maker equipment for concession area.

Improve fencing for the appearance and security of the front entrance and in other areas around the entire Community Pool complex. Baltusrol Golf Club has agreed to loan us their landscape architect, at no cost to the Township and to provide drawings and plans to improve the grounds of the Community Pool.

FINAL PRESENTATION OF THE SPRINGFIELD **MORRIS AVENUE CORRIDOR VISION PLAN**

The Township was awarded a competitive grant to create a "walkable downtown" for Springfield, which includes the Township's redevelopment area as well as commercially used or zoned lands along Morris Avenue and Mountain Avenue. The Vision Plan goals are the following:

- Creating a walkable and bike friendly downtown that is attractive to residents, visitors and businesses
- Providing safe and convenient pedestrian, bicycle and transit facilities
- Optimizing the locations of NJT bus stops and amenities
- Ensuring an adequate supply of efficient and convenient parking locations
- Mitigating future flooding

The project is being conducted in conjunction with the Township's ongoing redevelopment plan process and will result in recommendations that mitigate the auto-oriented nature of the area, improve bus stop locations and amenities, promote mixed use development in the downtown, improve environmental conditions, and manage parking. To learn more about the Springfield Morris Avenue Corridor Vision Plan:

BACKGROUND: The Morris Avenue Vision Plan is being developed to create a "walkable downtown" for Springfield, which generally includes the Township's redevelopment area as well as commercially used or zoned lands along Morris Avenue and Mountain Avenue. The project is being conducted in conjunction with the Township's ongoing redevelopment plan process and will result in recommendations that mitigate the auto-oriented nature of the area, improve bus stop locations and amenities, promote mixed use development in the downtown, improve environmental conditions, and manage parking. The Plan will

build upon the market analysis and retail assessment previously commissioned by the Springfield Business Improvement District.

At this meeting, the Project Team will present the recommendations of the plan. Prior to the presentation starting a 6 pm, attendees can move around to various exhibits structured by topic including:



JOIN RAHWAY RIVER WATERSHED CAMPAIGN TO BUILD 1000 RAIN GARDENS TAKES SHAPE FOR SPRING PLANTINGS

The Rahway River Watershed Stormwater Advisory Board, an organization of concerned citizens and officials, has been working on a goal of building 1000 rain gardens over the next two years in the 24 communities in the Rahway River Watershed from Millburn to Woodbridge.

Post Hurricane Irene and Sandy, the extreme weather patterns suggest a more significant approach is needed to managing storm water in the Rahway River Watershed.

Rain gardens, besides providing beneficial aspects to water quality, will help to increase the time of concentration on a regional basis providing flood waters "time to peak" which will then reduce the depth of water elevation in the river channels and then also reduce the width of over-the-bank flows.

Faced with the extreme prospects of a next storm, the advisory board has taken a major step to make this objective of reducing peak flow damage and will be working with private and public partners to encourage homeowners and commercial property owners to act on their own and to get municipal governments and school boards to implement a regional plan.

Some of the activities of the board include:

*Partnering with the Rahway River Watershed Association to train 30 or more citizens in how to build a rain garden. Training dates will be announced.

*Developing with the Rahway River Watershed Ambassador a marketing plan to encourage residents to create such gardens on their property.

*Supporting the effort to build rain gardens on municipal property including Springfield and Cranford's Municipal buildings and Taylor Park in Millburn.

*Partnering with several temples in Springfield to build signature rain gardens.

*Partnering with several commercial property owners to build rain gardens on their property.

Ten-year Life of Smoke Alarms

Working smoke alarms detect and alert people to fire in its early stages, providing the warning needed to escape safely. According to the nonprofit National Fire Protection Association (NFPA), *working* smoke alarms cut the risk of dying in reported home fires in half. However, smoke alarms don't work forever.

The Springfield Fire Department is concerned that the presence of smoke alarms in Springfield residents' homes (most U.S. homes have at least one) may give them a false sense of security. Oftentimes, people don't know how old their smoke alarms are, if they're still functioning properly, or at all. That lack of awareness can have deadly consequences: nearly two-thirds of all home fire deaths result from fires in homes with no smoke alarms or no *working* smoke alarms.

Smoke alarms more than 10 years old no longer offer a reliable level of safety. Springfield Fire Department urges all *Springfield Patriot Times* readers to determine how old their smoke alarms are. (The date of manufacture is located on the back of the alarm.) If they're 10 years old or older, replace them immediately! This includes smoke alarms that use 10-year batteries and/or are hard-wired.

In accordance with NFPA, Springfield Fire Department offers the following recommendations for buying and installing smoke alarms:

- Purchase combination smoke alarms or both ionization and photoelectric alarms.
- Make sure smoke alarms have the label of a recognized testing laboratory.
- Install smoke alarms in every bedroom, outside each sleeping area and on every level of
 the home, including the basement. (Some older homes may not have smoke alarms
 installed in bedrooms, but it's important that these locations include them to provide
 adequate warning.)

Time and time again, the Springfield Fire Department has witnessed the life-saving impact of smoke alarms. But we also know tragedy can result from smoke alarms that aren't working properly. We strongly encourage all *Springfield Patriot Times* readers to inspect their smoke alarms today, and to replace them, if necessary, as soon as possible.
