# RESIDENT RESCUED FROM SMOKE-FILLED APARTMENT

On April 17, 2010, at 2:59 am, the Springfield Fire Division dispatched all units to an apartment building at 279 Morris Avenue for an activated fire alarm. The first engine company arriving at the scene found the fire alarm sounding, but the building was not evacuated. Springfield Police Officer Foster Zeigler also responded to the scene and began assisting with evacuation.

Engine 3's crew encountered a moderate smoke condition coming from under the door of a second floor apartment. Upon confirming an active fire, Fire Captain James Anagnos transmitted a General Alarm calling for additional manpower. In the meantime, Firefighters Joseph Popolo and Walter Heckel entered the apartment with a hoseline to attack the fire. Firefighter Altay Vigilante secured a water supply from the hydrant. Firefighter Stewart Jurczak, using the thermal imaging camera, found a resident still sleeping. Firefighters were able to remove the disoriented man from his smoke-filled apartment.

The fire was confined to the apartment's kitchen and was quickly extinguished. Fire Chief James





# Message from the Mayor



I am happy to announce that I proclaimed May as Pedestrian Safety and Awareness Month in Springfield. Recently, the State of New Jersey revised traffic laws to provide additional protection for pedestrians. Our town has many active residents who wisely choose to walk instead of driving or walk for fitness reasons and the business community depends on patrons on foot. My initiative is possible thanks to cooperation from the Police Division under the leadership of Captain Davis. They have identified high traffic and dangerous crosswalks that they will target to

ensure motorists are following the law which requires drivers to come to a complete stop when a pedestrian enters a crosswalk. Similar enforcement programs have worked successfully, especially in nearby communities, and reduce the number of pedestrian accidents.

In a continued effort to provide effective representation, Committeeman Marc Krauss and I are drafting an ordinance to address concerned residents who are bothered by door-to-door solicitors. The new law will provide residents an opportunity to "opt-out" by subscribing to a "do-not-knock" list similar to the "do-not-call" registry. More information will be forthcoming.

As a result of unfortunate circumstances, the Township Committee was forced to disassociate from the Springfield Volunteer Fire Company. They are an independently selfgoverned group with their own by-laws. We did not disband or dissolve that Company as we are an outside party without that authority. However, their own membership committee, comprised of two members who are suing the town for jobs, sent notices to most of their members advising them of their options to either resign or be terminated. This left the Company with only three active members. Volunteers and family members contacted me because they were distraught over these actions. It reflected poorly on the Township although it was not something we or their own President could control. After repeated attempts to embrace and accommodate the Volunteer Fire Company, it had become an inadequate and unsustainable organization that could not serve the best interests of the Township. This troubled me greatly because volunteer recruitment, recognition and appreciation has been and is a major focus of my term. In response, I proposed an ordinance, 2010-10, that creates a position for volunteers within the Fire Division under the authority of the Chief. The ordinance also provides the volunteers with incentives, an opportunity for compensation and reassurances of hiring priority as paid members. Additionally, the ordinance reiterates our commitment to ensure more than the present adequate staffing levels by directing the Chief to schedule volunteers alongside paid members. Furthermore, the F.M.B.A. union was using outdated language in the ordinances to claim that they were staffed at levels below the authorized Table of Organization. The ordinance amends the Table of Organization by removing those positions that were either civilianized or are obsolete.

Our Township Administrator, Mr. Anthony Cancro, instituted a new "customer service survey" program to help me improve accountability in Town Hall. These forms can be found throughout the various municipal offices and seek your feedback regarding any interaction you may have had with municipal employees. Please take the time to complete and return the survey so we can continue to make improvements.

On Wednesday, May 19th at 6:00 p.m., join me in Town Hall for a friendly Property Tax Forum to discuss local property taxes, the impact of the economy on the municipal budget, our efforts towards fiscal responsibility and your ideas to reduce taxes. I look forward to seeing you!



# **NEWS FROM THE DPW REGARDING GRASS CLIPPINGS**

The Department of Public Works would like to advise Township residents that they may drop their grass clippings off at the DPW garage located at 54 Center Street from May 1st through October 23rd. The specific days the clippings may be dropped off are Tuesdays and Fridays, 7:00 am through 9:00 am. Clippings may be put in paper recyclable bags or in trash cans. Under no circumstances can Public Works accept any material placed in any type of plastic

In the spirit of environmental responsibility, the Public Works Department requests that all residents consider adopting a "cut it and leave it" approach to lawn care. A few facts regarding

leaving grass clippings on the lawn after cutting are listed below.

- Using a mulching mower will chop the clippings into fine pieces that are barely visible.
- Grass clippings contain 80 to 85% water and decompose very quickly when left on the lawn.
- Clippings help keep moisture in the soil for a longer period of time, reducing the need for frequent watering.
- Up to 25% of a lawn's total fertilizer needs can be met if cuttings are left on the lawn.
- Average mowing time can be reduced by 30% when clippings are not bagged.

# **GREENING SPRINGFIELD IS ON TRACK** TOWARDS SUSTAINABILITY CERTIFICATION

In order to be certified as a "Bronze Level to make Springfield green are: Sustainable Community" by the Sustainable Jersey program, Greening Springfield has identified and is implementing community initiatives that reflect our Township's commitment to sustainability. Here are a few things that have already been accomplished by our active community:

- Created a demonstration rain garden in front of the annex building across from town hall
- Recycling in all municipal buildings
- Farmers Market in town which promotes local NJ farms
- Cut it and Leave it Did you know that leaving cut grass on your lawn is better for the environment since the "waste" is converted to fertilizer and helps the sod to retain more moisture?

Department of Public Works has put recycling bins throughout the parks and fields including basketball courts, soccer fields, and playgrounds Additional items that the team is working on

- Energy Audits on municipal buildings
- Evaluating rooftops on municipal buildings for solar panels. This county program will allow us to install them free of charge benefit from a discount on our energy bills
- Putting together a Green Business Recognition Program, which will educate local businesses on sustainable practices and promote these businesses in the community.
- Establishment of a Greening Springfield Education Series, which held its first lecture on Your Carbon Footprint at the Springfield Library

Historic Preservation is also one of many ways to get points for community sustainability. The Springfield Historical Society is starting restoration work on the Cannon Ball House, which is an important part of Springfield's revolutionary history. Structural restoration will make it possible for the house to be open to the public this summer.

#### **FUTURE EVENTS:**

On May 26th, Greening Springfield Education Series will be showing the short film "The Story of Stuff" (appropriate for all ages) followed by a discussion at the library at 7pm. In cartoon form, this film "takes viewers on a provocative and eye-opening tour of the real costs of our consumer driven culture-from resource extraction to iPod incineration."

In conjunction with the Chamber of Commerce, Greening Springfield is planning a street fair this October, where there will be a "green zone" comprised of green vendors and educational booths.





# **FOOD FOR THOUGHT: GRILL SAFETY**

Memorial Day is fast approaching and the holiday is a popular time to host a barbeque. Here are some tips to keep your barbeque memorable for all the right reasons.

Each year, fire departments nationally respond to nearly 8,000 grill fires. Nearly 3,000 of those fires spread to a nearby structure – usually the house. Grill fires cause an annual average of 10 deaths, 120 reported injuries, and \$80 million in direct property damage. In half of the grill-related home fires, 86% of the time the fire started when either the flammable or combustible gas or liquid propane caught fire.

One-third of the structure fires involving grills started on an exterior balcony or unenclosed porch, which is why for people living in multiple residential properties (multi-family homes, apartments and condominiums), open flame cooking devices are prohibited for use on balconies. They are also prohibited within any interior spaces, within 5 feet of combustible exterior walls or openings in exterior walls (doors and windows), and under any building overhangs. Portable LP-gas grills are not to be stored indoors or within 5 feet of combustible portions of the building.

Propane and charcoal BBQ grills should only be used outdoors. The grill should be located well away from the home, deck railings and out from under eaves and overhanging branches. Keep children and pets away from the grill area. Keep your grill clean by removing grease or fat buildup from the grates and in the tray below the grill. Never leave your grill unattended.

There are several ways to get the charcoal ready to use. Charcoal chimney starters allow you to start the charcoal using newspaper as a fuel. There are also electric charcoal starters, which do not use fire. Be sure to use an extension cord rated for outdoor use. If you use a starter fluid, use only charcoal starter fluid. Never add any flammable liquids to an existing fire and keep charcoal fluid out of the reach of children and away from heat sources. When you are finished grilling, let the coals completely cool before disposing of them in a metal container.

Although gas grills are only used 1.5 times more often than charcoal grills, they were involved in five times as many fires. Each year you should check the gas tank hose for leaks by applying a light soap and water solution to the hose before turning it on. A propane leak in the hose will cause soap bubbles. If your grill has a propane gas leak, by smell or the soapy bubble test, and there is no flame, turn off the grill and the gas tank. If the leak stops, get the grill serviced by a professional before using it again. If the leak does not stop, call the fire department. If your grill is natural gas, turn off the grill and the pipe running to the hose. If you smell gas while cooking, turn off the grill and immediately get away from the grill and call the fire department. Do not attempt to move the grill.

If your grill does catch fire, turn off the gas, do not pour water (or any other liquid!) on a grease fire, keep the lid closed to deprive the fire of oxygen, and call the fire department. We'll do our best to save your barbeque.

# **CANNON BALL HOUSE GETS FUNDING**

After two years of effort, the Springfield Historical Society has finally found funds to proceed with urgently needed alterations at Cannon Ball House. "This has been a very trying time" reported Margaret Bandrowski, president of the Society. "During this period, we went through the tedious process of applying for funds to a number of grant agencies. All were refused, citing the general economic climate. Now, at last, we're able to proceed".

Cannon Ball House is believed to date to 1741. It was built on the ground over a grid of unbarked tree trunks. In 1920, the building was raised and a cellar was constructed, retaining the original tree trunks as the support for the first floor. These ancient logs have gradually weakened to the point where it threatened the stability of the first floor. In the interest of safety the building was closed to the public, requiring

the cancellation of all public events.

The Society has already spent \$15,000 of its own money in preparatory work. For the actual construction, major funding is now being provided by the Preserve Union County Grant Program and by the Ambrose and Ida Fredrickson Foundation and by Kearney Federal Savings Bank.

These sums are sufficient to cover the first half of the project, which will permit reopening of the house to the public. A pending application for more funds may make it possible to complete the longer range program of improvements.

Bandrowski announced that a construction contract has been signed, after a competitive bidding process. The work will be done in accordance with designs by Keller & Kirkpatrick, Engineers and with the approval of the New Jersey Historic Preservation Office.






