

## Message from the Mayor

Dear Neighbors,



As part of this year's state budget, Governor Murphy announced the investment of \$2 billion in property tax relief. Under this largest tax relief program in state history, up to 2 million New Jersey taxpayers will now be eligible for a rebate or tax credit.

This new expanded program, now known as ANCHOR, short for the Affordable New Jersey Communities for Homeowners and Renters, replaces the Homestead Rebate and expands the number of eligible residents. It has several different qualifications and new income limits so please read carefully to determine your eligibility.

DO YOU QUALIFY?

If you owned or rented your main residence on October 1, 2019 and meet the following income requirements, you qualify for property tax relief under the ANCHOR Program. Ownership and income requirements are based on your 2019 tax filing status.

- Property owners with incomes of less than \$150,000 are eligible for \$1,500 in property tax relief.
- Property owners with incomes between \$150,000 and \$250,000 are eligible for \$1,000 in property tax relief.
- Renters with incomes of less than \$150,000 will receive \$450 rebate.

HOW TO APPLY?

Most eligible residents should have received an ANCHOR mailing from the NJ Division of Taxation that includes your PIN and Login information to file online. If you have not received a mailing, please visit https://www.nj.gov/treasury/taxation/ or call the helpline at 1-888-238-1233.

The application deadline for paper or electronic submission is December 30, 2022.

#### **STOP ORDER ISSUED ON "GOMES" PROJECT**

#### Statement by Mayor Alex Keiser at the Township Committee Meeting:

"Today, the Township issued a Notice declaring Springfield Center Urban Renewal, the Redeveloper of the Morris Avenue Redevelopment Project, in default under the Redevelopment Agreement between the Township and the Redeveloper.

As you may be aware, the prior buildings were demolished in 2019. However, construction of the Project since then has been slow. The Township has been monitoring the progress at the site nearly daily and has exhausted other means in an effort to assist the Redeveloper in construction of the Redevelopment Project.

At this time, based on the fact the Redeveloper has not performed any meaningful work in some time, has failed to meet deadlines specified in the Redevelopment Agreement, failed to provide inspection and progress reports to the Township as required under the Redevelopment Agreement, and most recently, changed plans without proper approvals from Township officials, which caused the Township to issue a Stop Construction Order and a Notice of Unsafe Structure, the Township has issued the Default Notice to avail itself of certain legal remedies under the Redevelopment Agreement.

The Redeveloper now has a deadline to cure - or fix - all of the defaults. That time period can extend to 120 days, before the Township can take further action. The Township Committee and the Building Department remain concerned about the progress of construction on the site. The Township will do whatever is legally available to it to move this project forward and continue to develop the Township for the benefit of all our residents."

#### 9-11 ATTACKS

On Sunday morning, September 11th, Springfield's Emergency responders from Police, Fire, OEM, DPW & EMS gathered at Town Hall on the 21st anniversary of the attacks to pay tribute to those that had given their lives in the attacks. The solemn ceremony commenced at 830 am with Mayor Alex Keiser addressing the crowd together with Township Committeeman Rich Huber.

At 8:46 am, the Fire Department rang their bell to signify the first plane striking the North Tower. Following the bell being rung. At 9:03 am the bell was rung once again, the time at which the second plane stuck the South Tower. After this ceremony the group adjourned to Patriot's Park where a wreath was placed in front of the Adler-Heltibridle Memorial Garden. Elden Swindell, a Springfield Resident and piper, played Amazing Grace and Flowers of the Forest on his bagpipe.



#### HURRICANE SAFETY TIPS

#### Before a hurricane

If conditions are right for a hurricane in your area, this is how you can prepare:

- Stay tuned to local radio, official news and/or community websites, and TV for warnings, safety announcements or instructions.
- Have a bag ready and plan your evacuation route so you're prepared if leaving the area becomes necessary.
  - Stock up on emergency supplies but be aware others will need supplies, too.
- Reinforce the outside of your home, particularly doors, windows, walls and roofs.
- Move anything inside that could become flying debris in high winds, but only if there's enough time and it's safe to do so.
- Anchor outdoor items that are unsafe to bring inside, such as fuel tanks.
- If emergency officials haven't directed you to a public shelter, get your family to the basement, a closet, a small room or a hallway away from windows. The more walls between you and the outside, the better.

Review insurance policies and catalog your belongings, if there is time.3

#### **During the hurricane**

The decisions you make during the storm are crucial. Here are some actions you

- Follow any guidance from local officials. If you're told to evacuate, follow the plan you made and do so. Make sure you bring essentials like the bag you prepared before the storm.
- Stay away from windows. Keep yourself to the lowest, most interior section of your home as possible.
  - In the event of flooding, move to higher ground.
  - Never attempt to walk or drive through floodwaters.3

#### After a hurricane has passed

If you and your family were evacuated from your home – or if it has been severely damaged from the hurricane – wait for authorities to give the all-clear to re-enter. Then:

- Look for flooding in the wake of a hurricane and avoid it. Never attempt to enter floodwater.
- Be on the lookout for downed power lines, trees and poles. Some may still be upright but could still be highly unstable.
- Do not enter your home until it has been inspected for damage to the electrical system, gas lines, septic systems, and water lines or wells.
- If dark, use a flashlight not matches, a candle or a lighter. An open flame could ignite leaking gas.
- Avoid drinking any tap water until you get confirmation it's safe from local officials.
- If there is water damage, consider hiring a professional water damage cleaning service.
- Begin your cleanup as soon as possible washing and disinfecting items that have been touched by floodwater or disposing of items that cannot be saved. Protect yourself with gloves and sturdy, thick-soled shoes. Do not attempt to remove any heavy debris by yourself.
- Once you've gathered necessary documents and evidence of your claim (photos or video), contact your insurance company or agent.<sup>3</sup>

#### **HALLOWEEN SAFETY**

Since Halloween is right around the corner, I thought it would be best to utilize this month's column to remind readers of the Springfield Patriot Times about the importance of staying safe while enjoying Halloween festivities. I encourage all community members to follow the safety tips below to help make sure everyone has a safe and pleasant time on Halloween.

Parents should always accompany young children while they are trick-or-treating. Older children may be able to go by themselves, but they should always stay in a group with friends, use a preplanned route, and have an agreed time to 'check in' with their family. Also, having a flashlight, glow stick, cell phone, and possibly even a first aid kit is a good idea while trick-or-treating. Costumes should be bright and contain reflective strips, and should be made of flame-retardant material. Long trailing fabric could pose a tripping hazard or even a fire hazard, as some people use candles in jack-o-lanterns. Make sure that any costumes with masks do not limit a child's ability to see ahead of them and all around them. Also, toy guns may look real in the dark, so costumes should not contain toy weapons of any kind.

While trick-or-treating, children should never be allowed to enter a person's home, unless it is a very close friend or relative. Parents should inspect all candy their children receive, and discard any unwrapped items or treats that look questionable. Children should not be allowed to eat any treat that hasn't been checked first. Any candy that appears to have been tampered with should be reported to the police department immediately.

Trick-or-treaters should respect their neighborhoods. Although it may seem like fun, 'mischief' such as smashing pumpkins, 'egging', and spray painting are all illegal activities that damage a person's property and could subject you to summonses, fines, and other serious penalties. Parents should remind their children to be thoughtful of others when taking candy left at a front door and to not deliberately damage or take any items such as decorations from homes along their trick or treating route.

Drivers should be extra careful and cautious when heading out on Halloween, and expect to contend with large groups of children racing from house to house for treats. Drivers must remember that children will be excited and may be less cautious while walking. They should anticipate children crossing the streets randomly, and possibly darting out from between parked vehicles. Before dusk and all evening, drivers should proceed slowly and with lights on in order to see children in costumes. Drivers should not use their cellular phones, unless equipped with a hands-free connection.

For those of you who won't be venturing out for trick-or-treating, and if you anticipate children coming to your home, please do not use external decorations that are illuminated with candles, especially at your front door or along paths on which children would walk. Glow sticks or battery operated candles are much safer alternatives. Also, keep in mind that household pets may become irritated from the added excitement of children coming and going, so care should be taken to keep pets in a safe and secure area while you answer the door. (Also remember to secure the candy treats in your home so your pets cannot get at them as many types of Halloween treats can be poisonous if eaten by cats and dogs).



If you see anything suspicious or out of the ordinary, don't hesitate to call the police department or flag down a passing police officer







#### **SPRINGFIELD RECEIVES COUNTY GRANTS OF \$45,000 FOR TENNIS AND PICKLEBALL COURTS AND \$4,000 FOR TREES**

The Township of Springfield was awarded a \$45,000 grant from the Union County Kids Recreation Trust Fund and a \$4,000 grant from Greening Union County, on Thursday night, October 6, 2022, at a meeting of the Union County Board of County Commissioners. Mayor Alex Keiser commented, "I want to thank the Union County Commissioners for awarding this funding as this will allow us to improve and expand our recreational facilities. I can't wait to play on our new pickleball courts!"

The Department of Public Works will use its \$4,000 grant award to plant trees throughout Springfield. "On behalf of the Department of Public Works, I would like to thank the Union County Commissioners for continuing to support Springfield with another generous grant. The funds will help us keep Springfield Green with many new trees," said Robert Boettcher, Supervisor of Public Works. The Township is matching the Kids Recreation Trust Fund grant to finance the

renovation of several municipal tennis courts, plus the striping of several overlaid pickleball courts. The Township of Springfield maintains tennis courts at Irwin Park, Laurel Park, and Henshaw Park. The scope of the project -- which is expected to be undertaken in the first half of 2023 -- will include addressing tennis court damage, resurfacing several courts, constructing expansion joints, painting and striping tennis courts, and striping overlaid pickleball courts. According to Adam Lieb, Director of Recreation "We've been eyeing improvements to our tennis courts due to the age of the courts, resurgence of outdoor sports following the pandemic, and the growing popularity of pickleball. I'm really looking forward to seeing Springfield residents enjoying the newly resurfaced courts next

Matching grants from the Kids Recreation Trust Fund are distributed to municipalities across Union County that are looking to upgrade or build recreational facilities for children and families. Funds from the Greening Union County grant award help the Township offset the cost of planting trees throughout Springfield. Since its inception in 2004, the Kids Recreation Trust Fund has provided Union County communities with \$20+ million in funding.
