

#### 2010 BEGINS WITH NEW MAYOR AND TWO NEW COMMITTEEMEN

At the January 5, 2010 reorganization meeting of the Springfield Township Committee, Ziad Andrew Shehady was sworn in as Mayor and Marc Krauss and Jerry Fernandez were sworn into their first terms as Committeemen. Kim Guadagno, the state's first lieutenant governor elect attended to swear in all three. Other dignitaries in attendance were Congressman Leonard Lance, State Senator Tom Kean Jr., Assemblywoman Nancy Munoz and Assemblyman Jon Bramnick.

#### **MAYOR ZIAD ANDREW SHEHADY**

Township Committeeman Ziad Andrew Shehady was sworn in as Mayor at the Township's reorganization meeting on January 5, 2010. He is the youngest serving mayor in Springfield's history. He was sworn in as a Committeeman on January 1, 2008 after winning his first election in November 2007. In 2008, Ziad served as Chairman of the Public Safety sub-committee and in 2009, he served as the Chairman of the Finance and Revenue sub-committee and Vice-Chairman of the Public Safety sub-committee.

From 2005-2007, Ziad interned at the New Jersey Legislative District 21 offices and was later named Legislative Aide to the late Assemblyman Eric Munoz, M.D. Following 9/11, Mr. Shehady, 2nd Lieutenant, United States Army, enlisted in the military as an Infantry soldier in the Army National Guard. He served in the Global War on Terror in support of Operation Enduring Freedom from 2004 to 2005 and reached the rank of Sergeant before receiving his commission as a 2nd Lieutenant in August 2008. He is a member of the American Legion Springfield Post 228.

Long active in community service, Ziad decided to enter government service after graduating from American Legion Jersey Boys State, a leadership and citizenship program. He returns every year as a staff member and counselor. Ziad graduated from Jonathan Dayton High School in 2002 and received his Bachelor of Arts in Politics, French and Linguistics from New York University in 2007. In 2006, he was elected as President of the N.Y.U. Undergraduate Law Society.

Mayor Shehady is a first-generation American and the son of Ziad Elia and Sylvana Shehady. He is a member of Saint George Orthodox Church in Little Falls, N.J.

#### **MARC KRAUSS**

Township Committeeman Marc Krauss moved to Springfield with his wife Julie and son Judah more than a year ago. He is originally from Central Islip, NY. In 1982, Marc spent seven months working and learning Hebrew on a kibbutz in Israel. Marc enlisted in 1984 in the U.S. Air Force as satellite communications technician. After nearly 10 years of service Marc decided to finish his college education and became a full time student and simultaneously attended Army ROTC. In June of 1996, Marc was commissioned a 2LT in the Army as an Air Defense Artillery Officer. Marc was the logistics officer of a battalion in support of Operation Iraqi Freedom in 2003. His battalion crossed into Iraq on April 1st, 2003. Later, Marc commanded Charlie Battery and after command he served as an Army Liaison to the Air Force. He deployed a 2nd time to Iraq, just north of Baghdad. Marc's final assignment was at Fort Monroe, VA, where he retired after 21 years of active duty service at the rank of Major. Marc and his wife Julie are a JDate success story and were married six days after his retirement from the military in July 2008. Marc currently works as a government contractor as a Program Manager at Picatinny Arsenal outside of Dover, NJ. Marc served on the Springfield Board of Adjustments and Development Review Committee.

Marc holds three degrees, an MS in Project Management from the Florida institute of Technology, BA in Administration from the University of the Nebraska at Omaha, and an AAS in Electronic Systems Technology from the Community College of the Air Force.

#### **JERRY FERNANDEZ**

Township Committeeman Jerry Fernandez moved to Springfield four years ago. He was born in Newark and moved to Union where he graduated High School in 1988. His grandparents emigrated from Spain, and opened what is known as the first Spanish restaurant in the state of NJ in 1962. He, with his brother, continue the family tradition of owning and operating the family's second restaurant The Spanish Pavilion located in Harrison, NJ, which was also opened by their grandparents in 1976.

Jerry went to Johnson and Wales University upon graduating High School. He received an Associate in Hotel-Restaurant Management and a Bachelor in Hospitality Management. Jerry worked two years for Stouffers restaurant group managing two restaurants before going to work in the family business in 1994.

Jerry is on the board of directors for the New Jersey Restaurant Association and is on the Advisory board for the director of the Alcohol Beverage Control of New Jersey.

Jerry is married to Carmela DiMaria-Fernandez and has three children Alexander age 4, Christian age 2, and Robert who is 10 months old. Alexander currently attends Walton where Jerry is a member of the PTA and class dad.

#### Message from the Mayor

Excerpt from 2010 State of the Township Address



In recent years, the Mayor has only taken the oath of office as a member of the Township Committee. I insisted on taking an additional oath, this year as Chairman, not because the position of Mayor carries any extra power but because of the increased responsibility and trust associated with the position and because you the residents deserve a commitment that we strive to give you the best. The oath renews my promise to you that I will continue to perform the duties of Mayor to the best of my ability.

When I was elected two years ago, I did not imagine I would be in this seat. I ran on a platform to put Springfield first, as did Jerry and Marc. My prior service on the Committee can be characterized by the time and energy I have put into the job working to that end. Obviously, that is what taxpayers deserve and we will deliver.

As the Chairman, it is my job to ensure the Township Committee sets the standard moving forward for all employees and volunteers as a productive and responsible team. I am calling on the residents to hold us accountable in the performance of our duties. In turn, we will hold management and employees accountable for meeting performance standards in order to strive for a highly professional, business-like government. So that happens, there will be many changes in the coming months:

First, I am calling for a public 2010 Goal Setting Meeting on January 19th at 7 p.m. Our meetings will be consolidated into two public sessions per month. We will adopt by-laws and rules of conduct to guide our meetings. Each Committeeperson will report bi-monthly on activities in their supervisory roles on sub-committees. Department heads will be present at meetings to update the public. Our Administrator will be tasked to develop a management plan and a long-term plan. Evaluations, corrective action and management policies will be reviewed and revised. We will adopt a purchasing policy manual to regulate spending and provide fiscally responsible oversight. There are many more grants available that we will seek to increase revenue and offset the costs associated with development, green initiatives, and capital improvements. Additionally, I will ask that our Auditors scrutinize our operations more closely.

Communication is essential to identifying our town's strengths and weaknesses and must be greatly improved. Springfield will finally receive its own public access channel for broadcasting meetings and a bulletin board system. Our website will be overhauled to provide e-government services and friendlier access. I will continue to hold my regular open office hours to meet with residents, and my first as Mayor will be this Saturday, January 9th at 10 a.m.

I am proud to announce that Springfield will have a new Township Attorney who has the most municipal experience our town has ever seen and he will play an important role in this team as we work to improve our downtown. I am coordinating meetings between Economic Development agencies and our local businesses for more development and growth. This Saturday, January 9th at noon, I am leading this team on a door-to-door tour meeting with businesses to hear their needs and explain our goals for a better Springfield. We will continue to monitor enforcement and ask our officials to focus on the downtown. As other successful municipalities have done, we will pursue design standards and the implementation of Special Improvement Districts so that commercial property owners are required to make improvements. In order to cut spending and minimize bureaucracy, I am also proposing that this body consider combining the Planning Board and Zoning Board of Adjustment into one land-use board

This year's round of appointments and hiring will be apolitical so that experience and qualifications ensure the letter of the law is followed and services are efficiently rendered. Instead of the many layers of government that currently exist, the missions and activities of our boards and committees will be reviewed so that they can be consolidated. Our Green Team is an example for effective volunteer-based work. Our town is only as strong as the people working for it and public service is necessary for a robust and resilient community. At our next meeting, I will suggest the creation of a Springfield Improvement Team that will cultivate volunteerism and work towards several, broad initiatives including beautification, historical and cultural affairs, veterans outreach, downtown improvement and parks cleanup, green efforts, healthy living, employee appreciation, public relations and social activities

These are just a few examples of what residents can expect: access to government, common-sense solutions, taxpayer advocacy, and a community partnership so that we can continue to grow and improve

As anyone who serves on the Township Committee quickly learns, there are limitations and while not all of this will be completed by the end of my term, we will lay the foundation for a Springfield we can all be proud of. Our agenda will be aggressive and comprehensive because this governing body will put Springfield first always so that Springfield is number one.

Best wishes to all of you and your families for a blessed, healthy, and happy 2010. God bless Springfield and God bless America.

#### THREE H1N1 VACCINATION **CLINICS IN JANUARY**

The Westfield Regional Health Department, which covers Springfield as well as other area municipalities, has announced three H1N1 vaccination clinics for January, warning residents that New Jersey may not have seen the worst of the H1N1 virus.

Health Officer Megan Avallone said the clinics, which are open to everyone, will be held on Wednesday, Jan. 6 from 5 - 8 p.m. at Deerfield School in Mountainside; on Tuesday, Jan. 12 from 9 - 11 p.m. at the New Providence Senior Center and on Thursday, Jan. 21 from 5 -8 p.m. at Jonathan Dayton High School in Springfield. An increase in vaccine production from pharmaceutical companies is allowing the department to have more vaccine on hand than at previous clinics.

"We have plenty," Avallone said of her department's vaccine supply. "We have more than the demand."

#### Fire Chief's Column Chief James Sanford

#### **YEAR END REVIEW**

For the Springfield Fire Department, 2009 a year of challenges. professionalism, perseverance and dedication, we worked to address the challenges one by one and continued to provide fire-fighting, rescue, fire prevention and first responder medical service to the community.

To reduce costs, the Fire Department reorganized its fire prevention inspection work. The inspections were detailed to the firefighters working on the shifts. In order to increase the number of trained inspectors, the Fire Department conducted its own NJ Division of Fire Safety- recognized fire inspector course.

The Fire Department's overall call volume is lower for 2009 than for 2008. The decrease in the number of runs was the result of a change in the first responder medical program. The Fire Department's role in the emergency medical system was scaled back to provide back-up support to the Springfield First Aid Squad instead of having us respond automatically to all daytime medical calls.

The Fire Department experienced only a few minor firefighter injuries. Motorists on Route 78, however, were not as fortunate. Two motorists perished when their vehicle crashed and burnt. These two fatalities were Deaths – 2; Firefighter Injuries – 3; Firefighter Springfield's only fire-related deaths for the Deaths -0.

year. In early 2009, the highway claimed 6 lives in 6 weeks and during the third quarter, the number of motor vehicle crashes spiked. At one point, the Fire Department responded to the highway 8 times in a twenty hour

I'm very happy to report that the total number of fires in Springfield was slightly below average this year. There were 42 fires overall -- three of which were considered major fires where the buildings were damaged enough to displace the residents. There was one minor fire that was deliberately set. The number of false alarms has remained constant.

In 2010 the Fire Department will continue to improve firefighter training and we will be making additional enhancement to the fire prevention inspection program to better serve the community. We wish you a healthy and fire safe 2010!

speak about his love of his country, life in the Army, including his responsibilities and daily routine, the importance of a good education and much, much more.


The children also enjoyed handling the equipment Lt. Juleus brought in school which included his helmet, rain gear, medical kit and water carrier.

#### **IMPORTANT NOTES**

#### **GRASS COLLECTION**

At this point in time information regarding grass collection for 2010 has not been finalized. Currently, solutions are being sought to enhance our service in this area without increasing our costs. Notification regarding 2010 grass collection procedures will be forthcoming in the near future. Undoubtedly, the best alternative to grass collection is to adopt a "cut it and leave it" approach, which would completely eliminate the need for any money being expended for the collection of grass clippings.

A few facts concerning leaving grass clippings after cutting lawns are listed below;

- Using a mulching type mower will chop the clippings into fine pieces that are barely visible.
- Grass clippings contain 80 to 85 % water and decompose very quickly when left on the lawn.
- Clippings help keep moisture in the soil for a longer period of time, reducing the need for frequent watering.
- Up to 25% of a lawn's total fertilizer needs can be met if cuttings are left on the lawn.
- Average moving time can be reduced by 30% when clippings are not bagged.
- Contrary to myth, grass clippings do not cause thatch problems.

PLEASE NOTE: THE DPW CAN NOT PICK UP ANY MATERIALS IN PLASTIC BAGS.

#### **HAZARDOUS WASTE COLLECTION**

Union County sponsors free programs to collect hazardous waste such as aerosol cans, fluorescent light bulbs, antifreeze, caustics, cleaners, corrosives, oil based paints, etc. Dates are announced in the Spring and Fall. For more information call 908-654-9889.

#### **BULK WASTE DISPOSAL**

Bulk waste collection is conducted on a quarterly basis with collection to be either on a Wednesday or a Thursday, contingent upon your address.

For those residents whose weekly trash is collected on Tuesdays and Fridays, the bulk collection days will be on Wednesdays, March 24, June 16, September 22 and December 15.

Residents whose weekly trash is collected on Mondays and Thursdays, bulk waste collection days will be on Thursdays, March 25, June 17, September 23 and December 16.

All material should be out at curbside the evening before pick up.

#### NO APPOINTMENT IS NECESSARY.

Bulk waste is comprised of a collection of large and/or non-routine waste items collected on a quarterly basis. Bulk waste constitutes larger household waste including household furniture, appliances, light brush not to exceed six feet in length, bundled and tied and not to exceed 60 pounds, broken crockery, old clothing, carpeting, not to exceed six feet in length, rolled and tied, not to exceed 60 pounds, hot water heaters, and barbecue grills. Specifically excluded are construction material and debris such as sheet rock, lumber, pipe and paneling, concrete and large rocks, stones or logs greater than six inches in diameter, stumps and tree roots, recyclables, computer components, video games, propane tanks and all other hazardous waste. Refrigerators and freezers must have the doors removed. Please note, freon no longer has to be removed by the homeowner from air conditioners, freezers, and all other cooling devices.
